

National Vascular Registry - publication of consultant-level surgical outcomes in 2014

The National Vascular Registry will be publishing surgeon level information in 2014 on two procedures: abdominal aortic aneurysm (AAA) repair and carotid endarterectomy for all UK surgeons currently undertaking each procedure in NHS hospitals.

There will be two important changes to the process from last year. Firstly, individual consultants will not be required to give consent for their data to be published. Secondly, the results for 2014 will be made available on our website. They will not be available as a .pdf document.

For AAA repair, the Registry will publish outcomes for all elective, infra-renal procedures performed between 1 January 2009 and 31 December 2013. It will provide results for the past 5 years of practice. We will give information on the number of procedures performed, the average length of stay and postoperative inhospital mortality.

For carotid endarterectomy, we will publish outcomes for procedures performed between 1 October 2010 and 30 September 2013. It will provide results for 3 years of activity practice. We will report on the number of procedures performed, the average length of stay and the combined stroke and death rate at 30 days. We will produce the median delay from symptom to operation at NHS trust level. This median delay will only be based on the most recent 12 months of data (1 October 2012 to 30 September 2013).

Above are the timelines for data entry, showing the dates for data submission and analysis. Please ensure that you have your carotid endarterectomies and AAA repair cases submitted by **16**th **June 2014**.

Since 15 May, the data on these procedures in the NVD has been available in the NVR IT system. These records have been migrated as locked to ensure they were available for analysis.

Some migrated records were incomplete. Additional data can be entered but the records will need to be unlocked. To unlock records please contact the NVR helpdesk, the Northgate helpdesk or your local NVR administrator.

The records will then be subject to the NVR validation rules, and so all mandatory fields will need to be updated. Please contact the NVR helpdesk if this is going to be an issue as some fields are more important than others to be complete for inclusion in the analysis for surgeon level reporting this year.
